Porter SUD Discount Rate for Senior Citizens, Disabled, and Military Veterans

Discounted Base Rate

The discounted base rate is 50% of the regular base rate. The current base rate is \$13.00 per month, so the discounted base rate would be \$6.50 per month.

CONDITIONS

- 1. Only account holder may apply for discount and only one (1) discount per account
- 2. Discount rate applicant must show proof of qualifications:
 - a. Senior Citizen state of Texas or US Government ID showing age of 65 years or older at the time of application for discount
 - Disabled provide proof of Social Security or Veteran's Administration Disability Rating or show proof of Montgomery County, Texas providing disabled tax exemption in their name on the account property
 - c. Military military identification card showing qualifying status, DD-214
 Discharge forms showing qualifying status, or TDL showing veteran's
 endorsement; military veteran discount applies to current active duty and
 reservists as well
 - d. U.S. Government issued Resident Card
 - e. U.S. Government issued Passport or Passport Card
 - f. Alternate forms of identification may be accepted by the District's General Manager on a case-by-case basis
- 3. Discounts are not automatic and must be applied for by a qualifying customer
- 4. Discounts may only be applied to residential accounts
- 5. Applicant may only receive discount for one address within the District
- 6. Must show proof of residency at address for account

Porter SUD Discount Rate APPLICATION

The District's Senior Citizen, Disabled, and Military Veterans ("SCDMV") Discount Rate Program offers residential customers 65 years or older, disabled, and military customers a discounted rate of 50% on the monthly service charge. The current monthly service charge is \$13.00 per month, so the discounted rate would be \$6.50 per month. The discount rate is only applicable to the customer's primary residence.

Discount rate applicant must show proof of qualifications:

- i. Senior Citizen state of Texas or U.S. Government ID showing age of 65 years or older at the time of application for discount
- ii. Disabled provide proof of Social Security, Veteran's Administration Disability Rating, or show proof of Montgomery County, Texas providing disabled tax exemption in their name on the account property
- iii. Military military identification card showing qualifying status, DD-214 Discharge forms showing qualifying status, or TDL showing Veteran's Endorsement
- iv. U.S. Government issued Resident Card
- v. U.S. Government issued Passport or Passport Card
- vi. Alternate forms of identification may be accepted by the District's General Manager on a case-by-case basis
